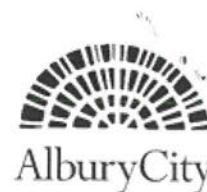


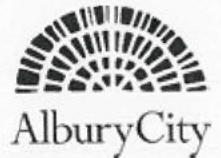
# Disclosures by Councillors and Designated Persons Return



Schedule 2 - Albury City Code of Conduct

<p>1. The pecuniary interests and other matters to be disclosed in this return are prescribed by Schedule 1 of AlburyCity's Code of Conduct.</p>
<p>2. <b>If this is the first return you have been required to lodge</b> with the Chief Executive Officer after becoming a councillor or designated person, do not complete Parts C, D and I of the return. You are also not required to enter a return period. All other parts of the return should be completed with appropriate information based on your circumstances at the return date – that is the date on which you became a councillor or designated person.</p>
<p>3. <b>If you have previously lodged a return</b> with the Chief Executive Officer <b>and you are completing this return for the purposes of disclosing a new interest that was not disclosed in the last return you lodged</b>, you must complete all parts of the return with the appropriate information for the applicable return period – that is either from 30 June of the previous financial year OR from the date on which you became a councillor or designated person (whichever is later date), to the return date which is the date you became aware of the new interest to be disclosed in your Additional return.</p>
<p>4. <b>If you have previously lodged a return</b> with the Chief Executive Officer <b>and are submitting a new return for the new financial year (annual return)</b>, you must complete all parts of the return with appropriate information for the previous 12 month period commencing on 30 June of the previous calendar year to 30 June this calendar year.</p>
<p>5. All councillors and designated persons are required to lodge a return in accordance with the following schedule:</p> <p>Within three (3) months after:</p> <ul style="list-style-type: none"> <li>a) Appointment to a role or position as a councillor or designated person ; and</li> <li>b) For each new financial year (After 30 June of previous financial year); and</li> </ul> <p>As soon as is practicable after:</p> <ul style="list-style-type: none"> <li>c) Becoming aware of any interest they are required to disclose that has not been previously disclosed under (a) or (b) above.</li> </ul>
<p>6. The particulars required to complete this form are to be written in <b>BLOCK LETTERS</b> or <b>TYPED</b></p>
<p>7. If any space is insufficient in this form for all the particulars required to complete it, an appendix is to be attached for that purpose which is properly identified and signed by you.</p>
<p>8. If there are no pecuniary interests or other matters of the kind required to be disclosed under a particular heading in this form, the word 'NIL' is to be placed in the appropriate space.</p>
<p style="text-align: center;"><b>IMPORTANT INFORMATION</b></p> <p>The information is being collected for the purpose of complying with clause 4.21 of the AlburyCity Code of Conduct</p> <p>You must not lodge a return that you know, or ought reasonably to know, is false or misleading in a material particular (see clause 4.23 of the AlburyCity Code of Conduct). Complaints about breaches of these requirements are to be referred to the Office of Local Government and may result in disciplinary action by AlburyCity, the Chief Executive of the Office of Local Government, or the NSW Civil and Administrative Tribunal (NCAT).</p> <p>The information collected on this form will be maintained by the Chief Executive Officer (CEO) of the council chambers in a register of returns. The CEO is required to table all returns at council meeting.</p> <p>Information contained in returns made and lodged under clause 4.21 of the AlburyCity Code of Conduct is to be made publicly available in accordance with the requirements of the Government Information (Public Access) Act, the Government Information (Public Access) Regulation 2009, and any guidelines issued by the Information Commissioner.</p> <p>You have an obligation to keep the information contained in this return up to date.</p> <p>If you become aware of a new interest that must be disclosed in this return, or an interest that you have previously failed to disclose, you must submit an updated (Additional) return within three (3) months of becoming aware of the previously undisclosed interest.</p>
